






## **PRIORITIES**

- ✓ Notification to Law Enforcement: "every second counts between the initiation of a threatening event and the arrival of emergency responders. Seconds and minutes equate to lives lost or saved." Sandy Hook Final After Action Report 2015.pdf (vermont.gov)
- ✓ Access Control / Building Exterior Doors:
   Ensure that building points of entry remain locked when they are not being monitored by staff. K-12 School Security Guide | CISA
- ✓ Access Control / Internal Doors:
  - "Classroom doors, for example, need to remain closed during instruction time if they are to delay intruders." CISA K-12 School Security Guide
  - "there has never been an event in which an active shooter breached a locked classroom door." Sandy Hook Final After Action Report 2015.pdf (vermont.gov)
- ✓ Emergency Communication to Students and Staff: "Multi-modal system is best to ensure delivery;" "Information about the nature of the emergency and what changes one needs to make immediately as a result;" <a href="CLERY CENTER">CLERY CENTER</a>
- √ Threat Recognition / Assessment: NJ Legislation Requiring Development of Threat Assessment Teams in 2023 / 2024
- ✓ Emergency Plans, Training and Exercises: The district board of education must develop and provide an in-service training program for all district board of education employees (NJDOE)



# **CURRENT BEST PRACTICES**

- ✓ The School Superintendent, Safety Specialist and Director of Technology demonstrated knowledge and commitment to the safety of students, teachers, and schools.
- ✓ The positive relationship between the Superintendent of Schools, Chief of Police and school and police leadership, is an exemplary example of the cooperation and integration necessary for the safety of students and staff and include the SRO Program, LEAD program, frequent unscheduled patrols of the schools and joint exercises.
- ✓ The campus exhibits the principals of Crime Prevention Through Environmental Design (CPTED).

  These principals include a physical environment that positively influences human behavior, has natural access control, natural surveillance, demonstrates territoriality, and is properly maintained. These CPTED principals will help prevent crime.
- ✓ The principals and school security officers demonstrated knowledge and commitment to the safety of students, teachers, and schools.
- ✓ The school security officers have a highly visible presence at assigned schools.
- ✓ Staff are provided with identification badges.
- ✓ All employees are vetted criminally at the time of employment and fingerprinted.
- ✓ Emergency Management Plan has been updated.
- ✓ Updated Emergency Response Guide.
- ✓ Staff security and emergency training completed.
- ✓ Risk Assessments Completed 2022.



- ✓ Alyssa Law Compliant Duress Alarms connected directly to the Montclair Police Department to speed response.
- ✓ The communication system has been upgraded throughout the district.
- ✓ A card access system has been installed for all school buildings.
- ✓ The main entrances are equipped with video/intercom systems to control visitor access.
- ✓ Updated Video Management System and cameras have been installed in Montclair High School and Annex and are being mapped for all other schools.
- ✓ A centralized "Security Console & Workstation" located at MHS to integrate the various technologies into a proactive model and enhance the effectiveness of Security Officers is in progress.
